

# COOKIE POLICY

Our website <https://paykilla.com> uses cookies.

This **Cookie Policy** (the "**Policy**") is an integral part of the **Privacy Policy** and regulates the interaction between the **Company** and you when you use the **Website**, as well as the **Company's** products/services. The **Policy** does not specify how we normally use your personal data.

**Company** – means **INGRASE Ltd.** (reg. number 245602), established and acting under the Law of the Republic of Seychelles.

A **cookie** - is a small data files that are placed on the browser of a visitor's device if agreed (such as computer, smartphone, tablet, etc.) when accessing online content and by which it is possible to recognise that device when it interacts with or returns to the **Website** The cookies may transmit information via your browser with a purpose of authenticating or identifying the computer (via e.g. the IP address) or the user. **Cookies** may contain information such as registration data and user preferences.

Before using the **Website** or the **Company's** products/services, you must carefully read this **Policy** governing your use of the **Website** and/or the **Company's** products/services offered. If you do not agree or do not understand any of the points of this Policy governing your use of the **Website** and/or the products /services offered by the **Company**, we ask you to stop using this **Website** and the products /services of the **Company**.

## 1. How we use Cookies

We use **Cookies** to distinguish you from other users of our site. Our **Cookies** help us to:

- 1) Manage the operation of the site so that it works in accordance with your expectations;
- 2) Record your preferences for the site during and between visits;
- 3) Improve the operation of our site, including its speed and security;
- 4) Use this information to improve the effectiveness and targeting of our marketing.

## 2. How can you turn Cookies off?

You may refuse to accept **Cookies** from our site at any time by activating the setting on your browser which allows you to refuse **Cookies**. Please note that by disabling or blocking any or all **Cookies**, some features of our site may not operate as intended and you may not have access to features or personalisation available on our site.

You can also disable non-essential **Cookies** within the **Cookies** preference centre available within the search engine settings at any time. How you can do this will depend on the browser you use. Most browsers have special privacy pages that explain how websites collect, handle, and pass on information to third parties.

### 3. What Types of Cookies Do We Collect and Use?

**Cookies** and similar technologies use unique codes that act as an identifier and, in certain circumstances, may be treated as personal data under the applicable data protection legislation. This is because they can enable the user of a device to be uniquely recognised as the same user, even if their “real world” identity is unknown. Please note that we may involve third-party service providers to collect and process certain **Cookies**.

#### **Cookies Types**

We collect essential and non-essential **Cookies**. Essential **Cookies** are required for the **Website** to operate properly. We do not need your consent to operate essential **Cookies** since these **Cookies** ensure basic functionalities and security features of the **Website**, anonymously. We are required to get your consent to operate the non-essential **Cookies**, used to analyse your behavior on the **Website** (e.g., analytical cookies).

Please note that third parties (including, for example, advertising networks and external service providers such as web traffic analysis services) may also use **Cookies** over which we have no control. These cookies may be:

- advertising – records information about your actions on the Internet, including visits to our Website, as well as information about links and ads that you have selected for viewing;
- analytical/productive – they allow you to recognize and count the number of visitors, as well as see how visitors move around the Website while using it;
- targeted – they register Users' visits to our Website, the pages they visited and the links they clicked through to.

### 4. Final provisions

The Company reserves the right to change this **Policy**. Any changes to this policy will take effect from the moment they are posted on the **Company's** website. The **Company** recommends that you periodically review this Policy for updates. In accordance with applicable law, we will ask you from time to time to update your consent to the use of cookies.
